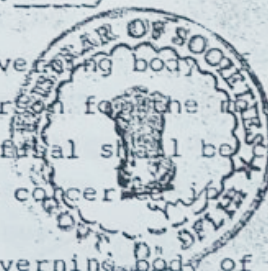


RULES AND REGULATIONS OF THE SOCIETY

1. NAME OF THE SOCIETY :- The name of the society shall be
'COSMOS EDUCATIONAL SOCIETY'
2. MEMBERSHIP :- The membership of the society is open to any Person or persons who has attained the age of majority and abide by the terms and conditions of the society, without discrimination of the religion, caste, colour or creed but subject to the approval of the governing body.
3. SUBSCRIPTION :- The rate of subscription for all the members shall be Rs. 20 /- per months and admission fee Rs. 25 /-
4. REFUSAL :- The governing body of the society may refuse any person for the membership provided reasons for refusal shall be communicated to the person concerned writing with reason.
5. EXPULSION :- The governing body of the society may expel any member from the society on the following grounds:-
- On his/her death.
 - If the member fails to pay the timely subscription continuously for three months from the due date of paying the subscription.
 - If the member works against the aims and objects of the society.
 - If the member tenders his/her resignation.
 - If the member fails to attend three meetings of general body and governing body.
- The reasons of expulsion shall be communicated to every member every such expelled member shall have a right to appeal before the general body which may or may not be accepted.
6. APPEALS :- All the appeals shall be preferred to the general body of the society, the decision of the general body shall be final. The reasons for rejection shall be communicated to the member concerned.



7. RE-ADMISSION :- In case of member expelled by the general body the same can be readmitted provided the member concerned, pays all upto date, dues. The decision of the general body shall be final.
8. RIGHTS & PRIVILEGE OF MEMBERS :- Every member shall have right to participate in the general body meeting and shall also be entitled to inspect the record of the association with prior approval of governing body. Besides this he/she shall have also right to vote in the meetings of the association. Every member shall be entitled to participate in the meetings functions and get-together programmes of the society. To inform the society pertained to any matter of the society.
9. GENERAL BODY :- There shall be a general body of the society consisting of all the members. The meetings of the general body shall be held after every one year with 1/3 quorum. No quorum shall be required in the adjourned meeting. An emergent meeting of the general body may also be summoned on the written request of 3/5 members with ten days prior notice for such meetings. The notice period of general body shall be ten days. The following business shall be transacted in these meetings. al
- a. To prepare annual programmes and policies.
 - b. To discuss and to decide all such other matters and issues which are directly or indirectly related to the affairs of the society.
 - c. To pass annual budget of the society.
 - d. To appoint a qualified auditor who will annually audit the accounts of the society's funds.
 - e. To consider any business brought for wards by the governing body.
10. GOVERNING BODY :- There shall be a governing body of the society to look after and to manage the day to day affairs of the society. It shall consist of minimum 7 and maximum 15 members including the office bearers. The meetings of the governing body shall be held after every two months with 1/3 quorum. No quorum required in the adjourned meeting. An emergent meeting of the governing body may also be summoned on the written request of 3/5 members by 10 days notice of the meeting. The notice period of the governing body shall be 10 days. The following business shall be transacted in the meetings:-
- a. To take necessary steps for the implementation of all the programmes and policies drawn by the general body.
