4. REFUSAL

The governing body the society may refuse any person for the matthe more person to the person concerned in a liting with reason.

5. EXPULSION

The governing hady of the society ma, expel any member from the society on the following grounds:-

- a. On his/her death.
- b. If the member fails to pay the timely subscription continuously for three months from the due date of paying the subscription.
- c. If the member works against the aims and objects of the society.
- d. If the member tenders his/her resignation.
- e. If the member fails to attend three meetings of general body and governing body.

The reasons of expulsion shall be communicated to every member every such expelled member shall have a right to appeal before the general body which may or may not be accepted.

6. APPEALS

RE-ADMISSION

In case of member expelled by the general body the same can be readmitted provided the member concerned, pays all upto date, dues. The decision of the general body shall be final.

- RIGHTS & PREVILEDGE OF MEMBERS :- Every member shall have right to participate in the general body meeting and shall also be entitled to inspect the record of the association with prior approval of governing body. Besides this he/ she shall have also right to vote in the meetings of the association. Every member shall be entitled to participate in the meetings functions and get-together programmes of the society. To inform the society pertained to any matter of the society.
  - GENERAL BODY :- There shall be a general body of the society consisting of all the members. The meetings of the general body shall be held after every one year with 1/3 quorum. No quorum shall be required in the adjourned meeting. An emergent meeting of the general body may also be summore with written request of 3/5 members with ten days prior notice far such meetings. The notice period of general e for bwing business shall be transacted in body shall be tendays these meetings.

- GOVERNING BODY :- There shall be a governing body of the society to look after and to manage the day today affairs of the society. It shall consist of minimum 7 and maximum 15 members including the office bearers. The meetings of the governing body shall be held after every two months with 1/3 quorum. No quorum required in the adjourned meeting. An emergent meeting of the governing body may also be summoned on the written request of 3/5 members by 10 days notice of the meeting. The notice period of the governing body shall be 10 days. The following business shall be transacted in the meetings:-
